## P O L I C I E S

## MINIMUM NIGHT STAYS

Minimum stays may vary according to the time of year-usually 2 nights during the winter, 3 nights during the spring and fall and $4-5$ nights during the summer. Please check with a Reservations agent on minimum-stay requirements for your specific dates.

## CHILDREN

Children three years of age and under are welcome to stay and enjoy daily meals at no charge. Children ages $4-11$ may stay for just $\$ 110$ per night. This rate includes daily breakfast, lunch and dinner. A litany of age-appropriate activities is available.

## GROUP RATES

Enjoy special group rates when reserving a block of accommodations for an event, meeting, wedding or family reunion.

## PET POLICY

Our pet package rates are an additional $\$ 50$ (per night) per pet, payable at the time of reservation. Dogs are welcome at Paws Up in select accommodations. Dogs are not permitted in our tented accommodations.

## ACTIVITIES

The Resort at Paws Up offers a vast menu of wilderness adventures that are included in your luxury home or luxury tent rates. Countless a la carte guided adventures are also available. All activities can be conveniently scheduled for you by our Concierge Services team. A litany of age-appropriate activities is available, and several allinclusive packages are also available.

## DINING

All nightly rates are inclusive of daily breakfast, lunch and dinner. Breakfast and lunch are served in Trough, The Resort's casual dining restaurant. For dinner you can choose from the refined cuisine at Pomp or in-home dining. Guests staying in a luxury camp experience breakfast and dinner in a private camp Dining Pavilion and lunch in Trough. ## RESORT FEE

The resort fee covers services such as round-trip airport transportation, all on-property transportation (on-demand drivers provided), use of a personal vehicle (for guests staying in homes), concierge services, complimentary Wi-Fi, the Paws Up App and access to the fitness center and an extensive trail system.

## GRATUITIES

The Resort at Paws Up is a gratuity-free resort. Our staff is dedicated to ensuring that you have a memorable vacation. Accordingly, all staff members are well-compensated and highly valued by the management and owners. If you'd like to recognize exemplary service, a kind note, a review on social media or a "thank you" is always appreciated but never expected.

TAXES
An $8 \%$ Montana state lodging tax will be applied to the nightly room rate. No sales tax is applied to food and beverages, spa services and wilderness adventures.

## DEPOSIT POLICY

For a guarantee of a reservation of one (1) or two (2) accommodations, a deposit equal to the first two (2) nights of the stay, before tax and resort fees, is required. The remaining balance will be collected 60 days prior to your arrival, including tax and resort fees. Reservations for one (1) or two (2) accommodations made within 60 days prior to arrival require full payment at the time of booking.

For a guarantee of a reservation of three (3) or more accommodations, a deposit equal to the first two (2) nights of the stay, before tax and resort fees, is required. The remaining balance will be collected 90 days prior to your arrival, including tax and resort fees. Reservations for three (3) or more accommodations made within 90 days prior to arrival require full payment at the time of booking.

## CANCELLATION POLICY

Reservation Size: one (1) or two (2) accommodations
All reservations of one (1) or two (2) accommodations are subject to a 60-day cancellation policy. Cancellation notification must occur at least 61 days prior to your arrival date to receive a partially refunded deposit. If you must cancel your reservation, we will refund your deposit, less a transaction fee equal to $20 \%$ of the deposit amount. Cancellation notifications made within 60 days of arrival are ineligible for a refund. No refunds will be issued for the cancellation of a portion of a reserved stay or a reduction in the size of your party made within 60 days of arrival.

Reservation Size: three (3) or more accommodations
All reservations of three (3) or more accommodations are subject to a 90-day cancellation policy. Cancellation notification must occur at least 91 days prior to your arrival date to receive a partially refunded deposit. If you must cancel your reservation, we will refund your deposit, less a transaction fee equal to $20 \%$ of the deposit amount. Cancellation notifications made within 90 days of arrival are ineligible for a refund. No refunds will be issued for the cancellation of a portion of a reserved stay or a reduction in the size of your party made within 90 days of arrival.

## RESERVATION POLICY/TRAVEL INSURANCE

A last-minute cancellation or date change gives us little chance of filling the space due to our remote location. For this reason, we uphold a strict deposit and cancellation policy. Should it be necessary for you to depart earlier or arrive later than your confirmed dates, you will be responsible for the original reserved room nights of your intended stay. The Resort at Paws Up highly recommends purchasing trip insurance from your local travel agent, credit card provider or insurance provider.
